COMMERCIAL ORDINANCE

WHEREAS, the City of Chicago ("City") is a home rule unit of local government pursuant to Article VII, Section 6 (a) of the 1970 constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the property at 12-14 E. Delaware Place is owned by Ten East Delaware, LLC; and

WHEREAS, Ten East Delaware, LLC is currently using the portion of the alley to be vacated herein as part of their Elysian Hotel building; and

WHEREAS, the City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to be subserved is such as to warrant the vacation of part of public alley described in the following ordinance; now therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That part of the East-West alley dedicated by instrument recorded February 3, 1886, as Document Number 688526, lying above a horizontal plane of elevation +33.86 feet (Chicago City Datum), and below a horizontal plane of elevation +108.92 feet (Chicago City Datum), in Block 12 in the Superior Court Partition of the East two thirds of Block 12 in Canal Trustees' Subdivision of the South Fractional Quarter of Section 3, all in Township 39 North, Range 14, East of the Third Principal Meridian, bounded and described as follows:

Beginning at the most Easterly Northeast corner of Lot 6 in the Superior Court Partition of the East two thirds of Block 12, aforesaid, thence North 89 degrees, 40 minutes, 59 seconds West, along the most Southerly North line of said Lot 6, being also the South line of the East-West 16 foot alley in Block 12, aforesaid, a distance of 16.78 feet to an angle corner in Lot 6 aforesaid; thence North 00 degrees, 19 minutes, 46 seconds East, along the most Westerly East line of Lot 6 aforesaid, 4.93 feet to the Easterly extension of the North line of an East-West 16 foot wide alley; dedicated by ordinance, recorded May 31, 2006 as Document Number 0615144102; thence South 90 degrees, 00 minutes, 00 seconds East, along said Easterly extension, 16.78 feet to the Northerly extension of the most Easterly East line of Lot 6 aforesaid; thence South 0 degree, 19 minutes, 51 seconds West, along said most Easterly East line, 5.02 feet to the point of beginning in Cook County, Illinois as shaded and indicated by the words, "HEREBY VACATED" on the drawing hereto attached, which drawing for greater certainty is hereby vacated and closed, inasmuch as the same is no longer required for public use and the public interest will be subserved by such vacation.

SECTION 2. The vacation herein provided for is made upon the express condition that within 180 days after the passage of this ordinance, Ten East Delaware, LLC shall pay or cause to be paid to the City of Chicago as compensation for the benefits which will accrue to the owner of the property abutting said part of public alley hereby vacated the sum _____ dollars (\$ _____), which sum in the judgment of this body will be equal to such benefits.

SECTION 3. The vacation herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, the applicant shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois a certified

copy of this ordinance, together with an attached plat of vacation approved by authorized staff of the Department of Transportation Maps and Plat Unit.


SECTION 4. This ordinance shall take effect and be in force from and after its passage. The vacation shall take effect and be in force from and after its recording.

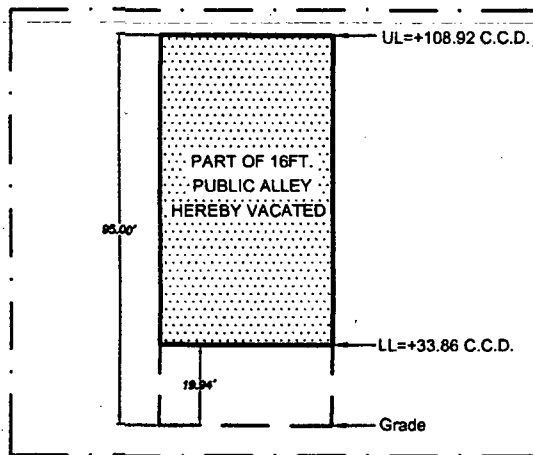
