**COMMERCIAL ORDINANCE**

WHEREAS, the City of Chicago ("City") is a home rule unit of local government pursuant to Article VII, Section 6 (a) of the 1970 constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the property at 7500-7510 W. Bryn Mawr Avenue and 7501-7511 W. Higgins Avenue are owned by Kazimierz and Bernadeta Krol; and

WHEREAS, Kazimierz and Bernadeta Krol are currently occupying the portion of the street to be vacated herein with their attached garage; and

WHEREAS, the City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to be subserved is such as to warrant the vacation of part of the public street described in the following ordinance; now therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That part of the Southwest Quarter of Section 1, Township 40 North, Range 13, East of the Third Principal Meridian in Cook County, Illinois described as follows: commencing at the Northwest corner of Lot 9 in Nordica Building Corporation Subdivision in said Section 1; thence Southeasterly along the Northerly line of said Lot 1 also being the Southerly line of a public right-of way known as West Higgins Road 83.47 feet for a place of beginning; thence Northeasterly 14.18 feet to a point 8.40 feet Northerly (as measured normal to) said Northerly line of Lot 9; thence Southeasterly 10.50 feet to a point on said Northerly line of Lot 9; thence Northwesterly along said Northerly line of Lot 9 a distance of 17.68 feet to the place of beginning; said parcel of land herein described being a part of said West Higgins Road public right-of-way and containing 17.4 square feet.

SECTION 2. The vacation herein provided for is made upon the express condition that within 180 days after the passage of this ordinance, Kazimierz and Bernadeta Krol shall pay or cause to be paid to the City of Chicago as compensation for the benefits which will accrue to the owner of the property abutting said part of public alley hereby vacated the sum \_\_\_\_\_ dollars (\$ \_\_\_\_\_), which sum in the judgment of this body will be equal to such benefits.


SECTION 3. The vacation herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, the applicant shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with an attached plat of vacation approved by authorized staff of the Department of Transportation Maps and Plats Unit.


SECTION 4. This ordinance shall take effect and be in force from and after its passage. The vacation shall take effect and be in force from and after its recording.

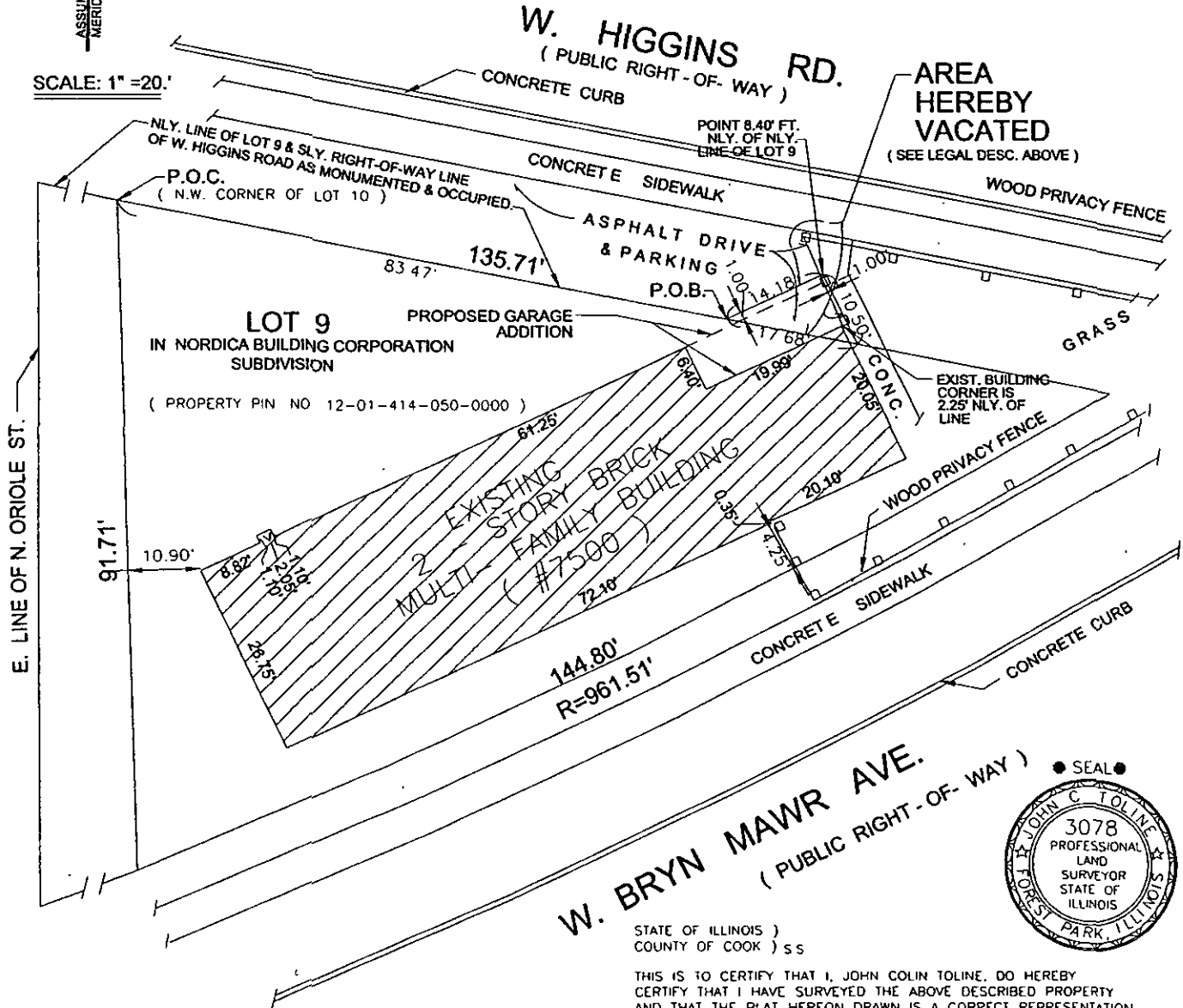
