ORDINANCE

WHEREAS, By ordinance passed by the City Council on November 16, 2011 for the 2012 fiscal year, the City Council authorized the projected use of Community Development Block Grant entitlement funds for Year XXXVIII (the "Year XXXVIII CDBG Ordinance"); and

WHEREAS, Pursuant to the Year XXXVIII CDBG Ordinance, the reprogramming of funds is subject to review and approval by the City Council; and

WHEREAS, The Department of Family and Support Services seeks to re-appropriate Year XXXVIII CDBG funds that have become available from delegate agencies that have closed their doors or otherwise been unable to comply with grant requirements; and

WHEREAS, On February 17, 2009, President Barack Obama signed into law the American Recovery and Reinvestment Act of 2009, pursuant to which the City has received Federal stimulus funding for a variety of important purposes, which were duly appropriated in an ordinance passed by the City Council in 2009 (the "CDBG-R Ordinance"); and

WHEREAS, Certain CDBG-R funds have become available as a result of current programs terminating without having fully expended their allocated funds, and thus the City seeks to salvage those funds, originally allocated to the Department of Housing and Economic Development, and re-appropriate them for use by the Department of Family and Support Services; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The Year XXXVIII CDBG Ordinance, as amended, is hereby further amended by striking the words and figures and adding the words and figures indicated in Exhibit A attached hereto.

SECTION 2. The CDBG-R Ordinance, as amended, is hereby further amended by striking the words and figures and adding the words and figures indicated in Exhibit B attached hereto.

SECTION 3. This ordinance shall be in full force and effect from and after its passage and approval.
