BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B2-3 (Type 1), Neighborhood Mixed-Use District symbols as shown on Map No. 2-G in the area generally bounded by:

West Monroe Street; the alley next west of and parallel to South Racine Avenue; the alley next south of and parallel to West Monroe Street; and a line 202.01 feet west of and parallel to South Racine Avenue

to those of a B2-3 (Type 1 as amended), Neighborhood Mixed-Use District.

SECTION 2. This ordinance takes effect after its passage and approval.


The building will be used for three residential units with 1:1 parking. The building is existing and contains 17,640 square feet with no setbacks. The existing height of the building is approximately 52'-1".



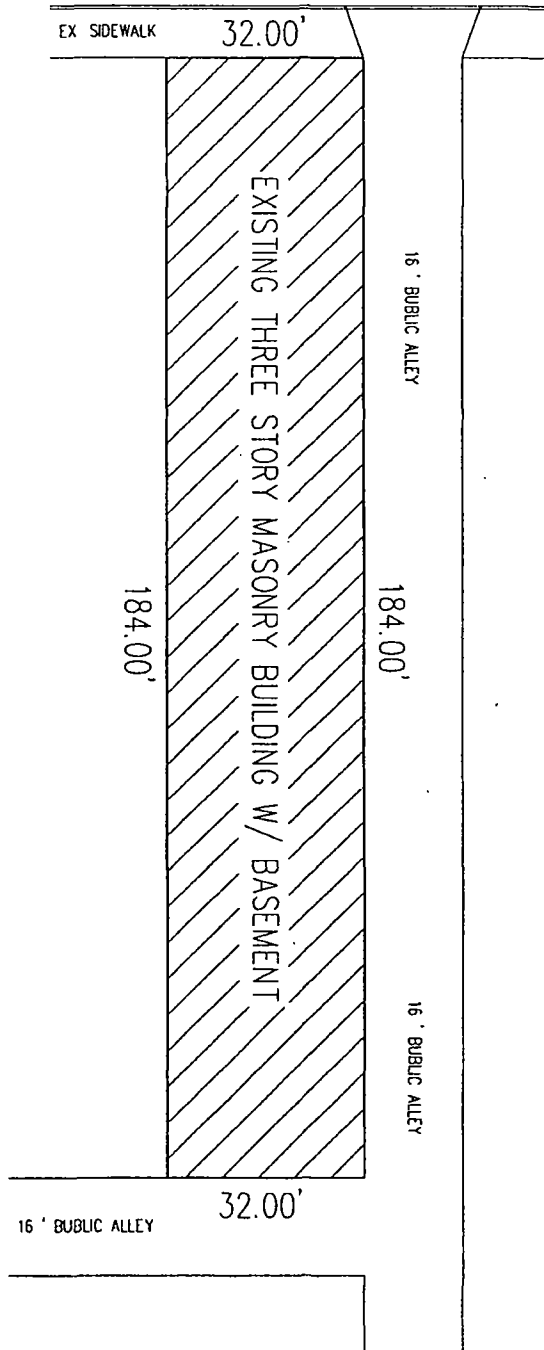
1217-19 West Monroe Street
Type 1 Narrative

The subject property was rezoned by the City Council on December 12, 2012 pursuant to a Type 1 Rezoning Ordinance. The current zoning designation is B2-3, Neighborhood Mixed-Use District. The previously approved Type 1 Ordinance restricted the use of the first and second floors of the building to personal training space, office and/or retail. This proposed amendment seeks to amend the Type 1 Ordinance by allowing residential use on the first and second floors.

The subject property is approximately 5,880 square feet in size. It is improved with a three-story building constructed circa 1889. The building is built to the lot lines and contains approximately 17,640 square feet of floor area. The proposed building will be renovated and will contain three residential units, one per floor. Floor plans are attached to this application. No addition will be constructed.

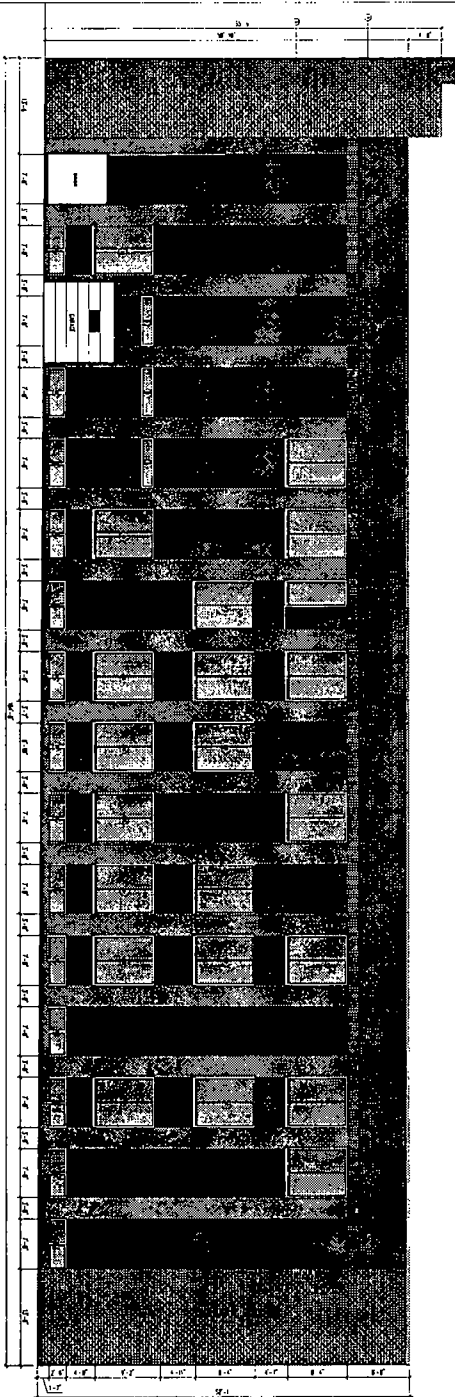

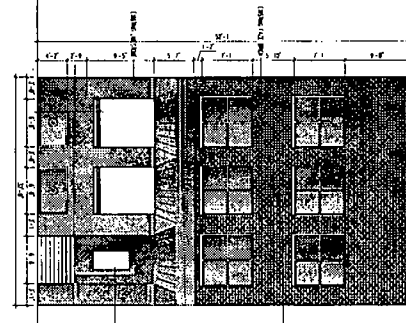

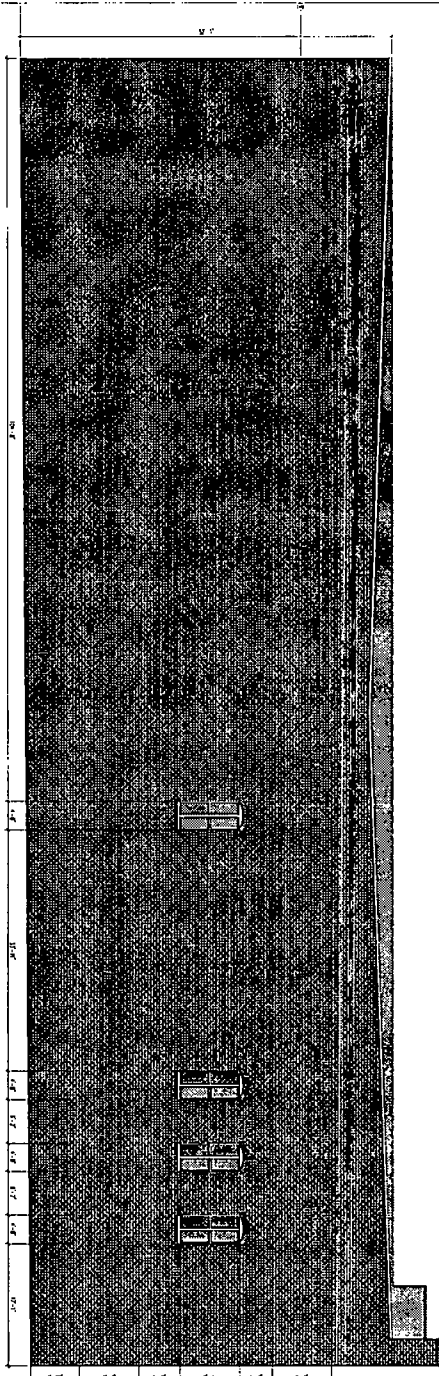
EAST ELEVATION

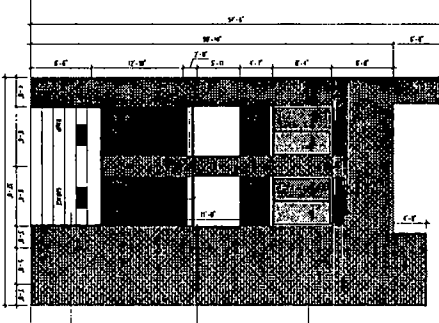
NORTH ELEVATION

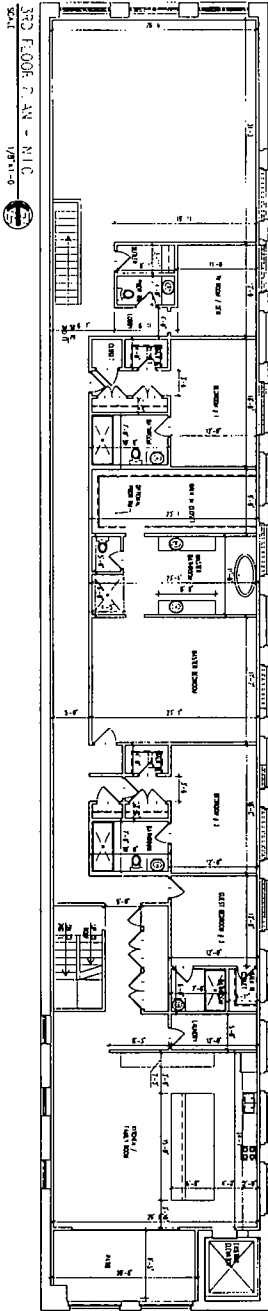

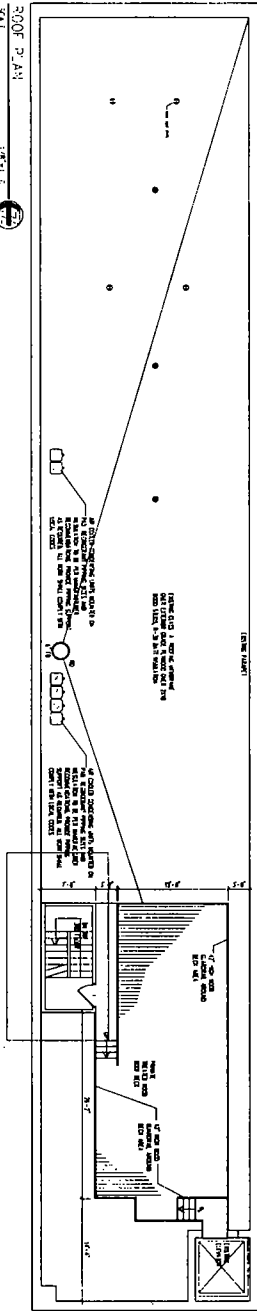

In compliance with the notice requirements for an Amendment to the Chicago Zoning Ordinance, please be informed that on or about April 2, 2014, an application for an Amendment to the Chicago Zoning Ordinance will be filed on behalf of 1217 W. Monroe, LLC, the Applicant, for the property commonly known as 1217-19 West Monroe Street.

The sole purpose of this technical amendment is to amend the B2-3 Type 1 zoning ordinance as approved by the City Council on December 12, 2012. The previous amendment required the first and second floors of the existing building to be used for personal training, retail and/or office uses, and the third floor was to be residential. This application seeks to amend the Type 1 zoning ordinance to allow the first and second floors to be used as residential units. There will be no additions to the existing three-story building. Upon completion of the interior work, the existing building will contain three residential units. The zoning designation will remain as B2-3 Type 1, as amended.


