ELM STATE PROPERTY LLC

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to ELM STATE PROPERTY LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use two (2) Canopy(s) projecting over the public right-of-way adjacent to its premises known as 4 E. Elm St..

Said Canopy(s) at E. Elm Street measure(s):

One (1) at thirty-six point two five (36.25) feet in length, and seven point nine two (7.92) feet in width for a total of two hundred eighty-seven point one (287.1) square feet.

One (1) at seventeen point zero eight (17.08) feet in length, and point seven five (.75) feet in width for a total of twelve point eight one (12.81) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1114114 herein granted the sum of one hundred eleven dollars and twenty-five cents (\$111.25) per annum in advance.


A 25% penalty will be added for payments received after due date.

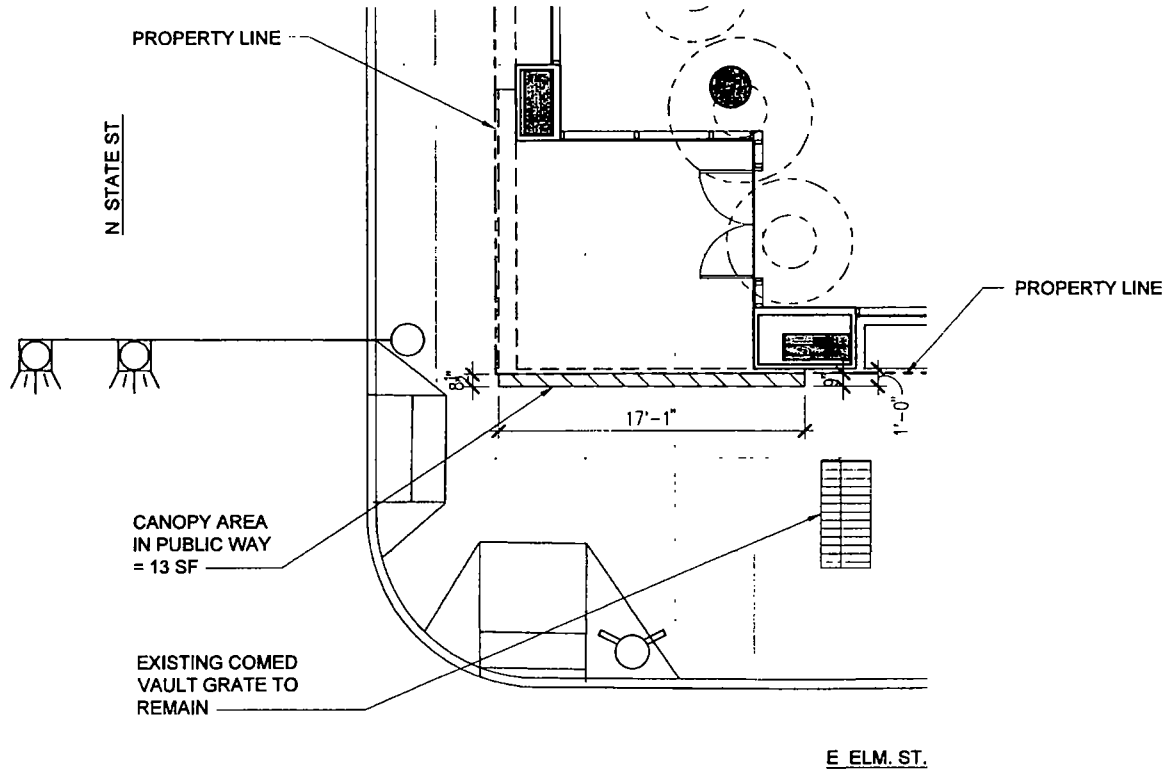
