BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all B2-3 Neighborhood Mixed-Use District symbols and indications as shown on Map No. 13-H in the area bounded by

The alley next north of and parallel to West Lawrence Avenue; A line 56.93 feet west of and parallel to North Leavitt Avenue; West Lawrence Avenue; and a line 157.18 west of and parallel to North Leavitt Avenue

to those of a B2-3 District Neighborhood Mixed-Use District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

TYPE 1 ZONING AMENDMENT

2208 West Lawrence Avenue

B2-3 Neighborhood Mixed-Use District

The applicant is requesting a zoning amendment from a B2-3 Neighborhood Mixed-Use District to a B2-3 Neighborhood Mixed-Use District to establish a mandatory Type 1 Zoning Amendment which expired seeking the transit served location as per section 17-10-0102-B in order to allow for the proposed construction of 2 multi-family buildings containing 10 residential dwelling units for a total of 20 residential dwelling units. The Applicant proposes to construct 18 indoor parking spaces for the proposed development. Each building will be five-stories in height. The property is a transit served location within 1,250 feet from the CTA Bus Western Line.


