**ORDINANCE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** Section 4-60-022 of the Municipal Code of Chicago is hereby amended by inserting the language underscored, and by deleting the language struck through, as follow:

**4-60-022 Restrictions on additional licenses.**

Subject to the provisions of subsection 4-60-021 (c), no additional license shall be issued for the sale of alcoholic liquor, for consumption on the premises within the following areas:

(42.289) On the ~~west~~ east side of State Street from Haddock Place to Wacker Drive; and on the south side of Wacker Drive from State Street to Wabash Avenue.

*(Omitted text is unaffected by this ordinance)*

(42.300) On the west side of Michigan Avenue from Madison Street to Monroe Street; and on the north side of ~~Madison~~ Monroe Street from Michigan Avenue to Garland Court

*(Omitted text is unaffected by this ordinance)*

(42.342) On the west side of State Street from ~~Benton Couch~~ Couch Place to Randolph Street; and on the north side of Randolph Street from State Street to Dearborn Street.

(42.343) On the east side of Dearborn Street from Randolph Street to ~~Benton Couch~~ Couch Place; and on the south side of ~~Benton Couch~~ Couch Place from Dearborn Street to State Street.

(42.344) On the west side of State Street from Lake Street to ~~Benton Couch~~ Couch Place; and on the north side of ~~Benton Couch~~ Couch Place from State Street to Dearborn Street.

(42.345) On the east side of Dearborn Street from ~~Benton Couch~~ Couch Place to Lake Street; and on the south side of Lake Street from Dearborn Street to State Street.


(42.347) On the east side of Dearborn Street from Lake Street to ~~Wacker Street~~ Drive; and on the south side of Wacker Drive from Dearborn Street to State Street.

(42.348) On the west side of Dearborn Street from ~~Wacker Street~~ Drive to Lake Street; and on the north side of Lake Street from Dearborn Street to Clark Street.

(42.349) On the east side of Clark Street from Lake Street to Wacker Street Drive; and on the south side of Wacker Street Drive from Clark Street to Dearborn Street.
