## ORDINANCE

**WHEREAS**, the City of Chicago (the "City"), a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, has heretofore found and does hereby find that there exists within the City a serious shortage of decent, safe and sanitary rental housing available for persons of low and moderate income; and

**WHEREAS**, the City has determined that the continuance of a shortage of affordable rental housing is harmful to the health, prosperity, economic stability and general welfare of the City; and

**WHEREAS**, Covent Apartments, LLC, an Illinois limited liability company (the "Borrower"), of which Covent NHPF Manager, LLC, an Illinois limited liability company, is the managing member, will acquire certain property located generally at 2653 N. Clark Street in the City (the "Property"); and

**WHEREAS**, the Borrower has proposed a certain low- and moderate-income housing development project on the Property consisting of the rehabilitation of one building, currently containing approximately 64 rental units, together with certain common areas and other building amenities (the "Building"), which will be rehabilitated to reduce the total number of rental units to approximately 30, all 30 of which, together with an applicable portion of such building and common area amenities (the "Project"), are expected to be financed in whole or in part with the proceeds of the hereinafter mentioned Bonds; and

**WHEREAS**, the Borrower has requested that the City issue multi-family housing revenue bonds, notes or other indebtedness in an amount not to exceed \$12,000,000 (the "Bonds") for the purpose of financing a portion of the Project costs; and

**WHEREAS**, it is intended that the interest on the Bonds will be excluded from gross income for federal income tax purposes; and

**WHEREAS**, it is intended that this ordinance shall constitute a declaration of intent to reimburse certain eligible expenditures for the Project made prior to the issuance of the Bonds ("Eligible Project Costs") from the proceeds of the Bonds (if and when issued) within the meaning of Section 1.150-2 of the Treasury Regulations promulgated under the Internal Revenue Code of 1986, as amended (the "Treasury Regulations"); now, therefore,

### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein

**SECTION 2.** The City intends to issue the Bonds and lend all or a portion of the proceeds thereof ("Bond Proceeds") to the Borrower for the purpose of financing a portion of the Project costs, subject to the City and the Borrower agreeing to the terms and conditions necessary to issue the Bonds and further approval by the City Council of the City. The maximum principal amount of Bonds which the City intends to issue for the Project will not exceed \$12,000,000.

**SECTION 3.** Certain Eligible Project Costs will be incurred by the Borrower or an entity affiliated with or related to Borrower in connection with the Project prior to the issuance of the

Bonds The City reasonably expects to reimburse such Eligible Project Costs with Bond Proceeds.

**SECTION 4.** The Eligible Project Costs to be reimbursed with Bond Proceeds will be paid initially from funds of the Borrower or an entity affiliated with or related to Borrower.

**SECTION 5.** This ordinance is consistent with the budgetary and financial circumstances of the City. No funds from sources other than Bond Proceeds are, or are reasonably expected to be, reserved, allocated on a long-term basis or otherwise set aside by the City for the Project for costs to be paid from Bond Proceeds.

**SECTION 6.** This ordinance constitutes a declaration of official intent under Section 1.150-2 of the Treasury Regulations.

**SECTION 7.** To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code of Chicago, or any part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

**SECTION 8.** This ordinance shall be effective as of the date of its passage and approval.







Remedies at law for a false statement of material fact may include incarceration and an award to the City of treble damages.

Some or all of the information provided in, and appended to, this EDS may be made publicly available on the Internet, in response to a Freedom of Information Act request, or otherwise. By completing and signing this EDS, the Disclosing Party waives and releases any possible rights or claims which it may have against the City in connection with the public release of information contained in this EDS and also authorizes the City to verify the accuracy of any information submitted in this EDS.






