## You Are Protecting Vulnerable Voters: Ruthelle Frank

Ruthelle Frank, a feisty 89-year-old resident of Brokaw, Wisconsin, has voted in every election since 1948. Ever since Wisconsin introduced harsh voter ID laws, she can no longer vote. The reason? She doesn't have a birth certificate and her maiden name is misspelled on her government records. For five years now, Ruthelle and the ACLU have been challenging these laws.

## You Are Standing Up for People Jailed for Being Poor: Joseph Anderson

Joseph Anderson, a survivor of multiple heart attacks and a stroke, was getting by one day at a time on Social Security. When Biloxi, Mississippi police arrested him for an outstanding \$200 traffic fine, they gave him two options — pay up or stay in jail. He was locked up for seven nights before finally being released. The ACLU took his case and won sweeping reforms.

## You Are Helping Women Protect Their Rights and Their Health: Tamesha Means

ACLU client, Tamesha Means, was 18 weeks pregnant when her waters broke. She rushed to the only hospital close by, Mercy Health Partners in Michigan. Following U.S. Conference of Catholic Bishops rules that prohibit Catholic hospitals from providing an abortion, even if the woman's life is at risk, the hospital turned her away. The doctors never told Tamesha that the fetus wasn't going to make it and the safest course would be to terminate the pregnancy.

Tamesha was refused treatment two more times. It wasn't until she started to deliver while being discharged that the hospital admitted her.


