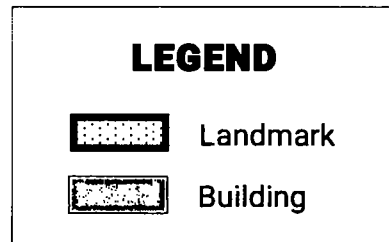
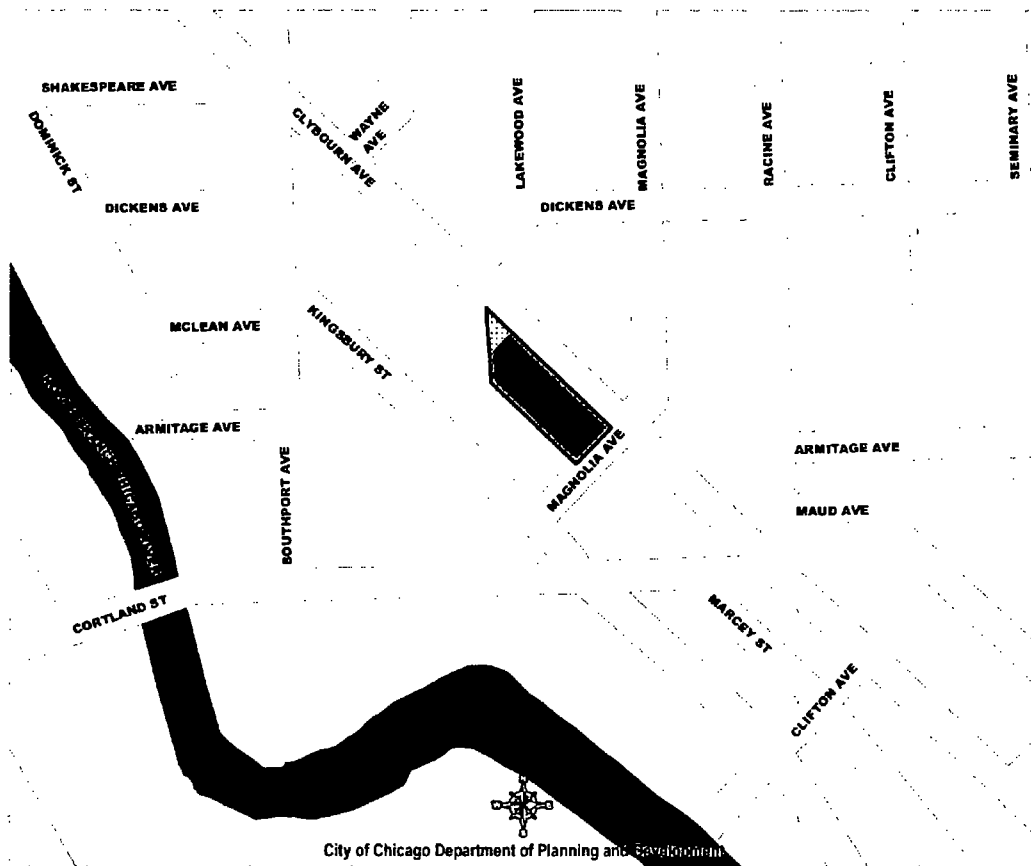

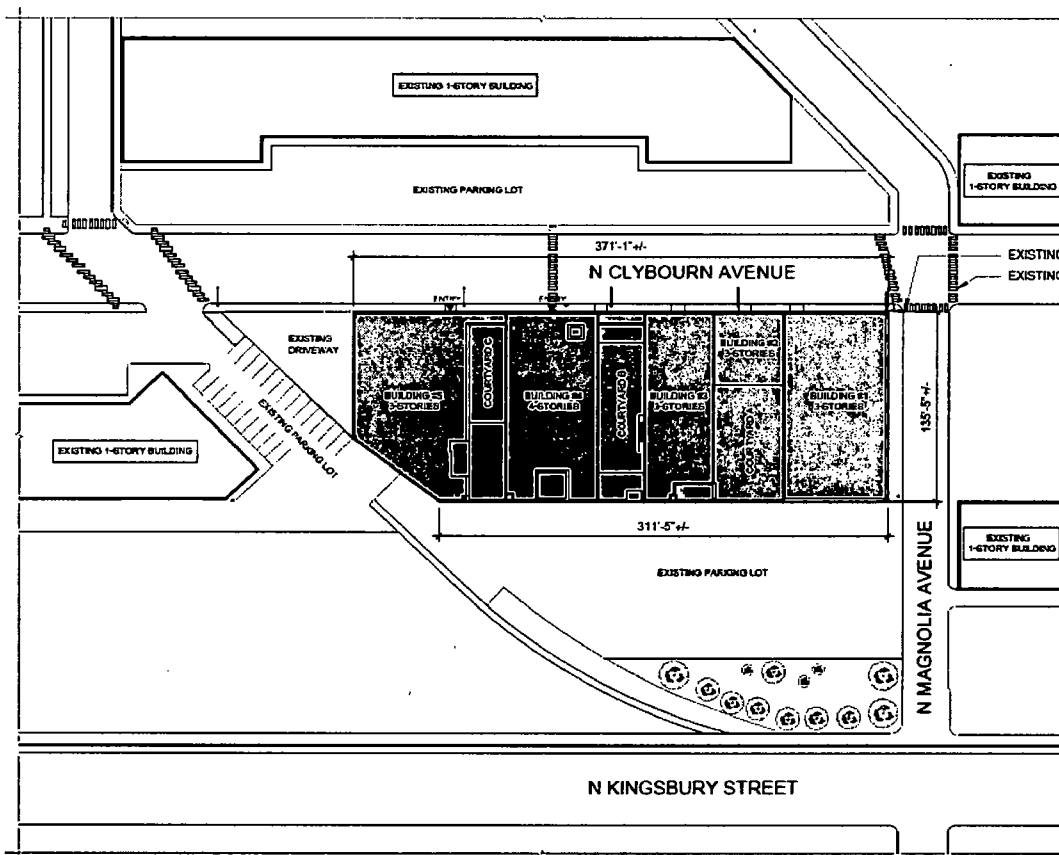

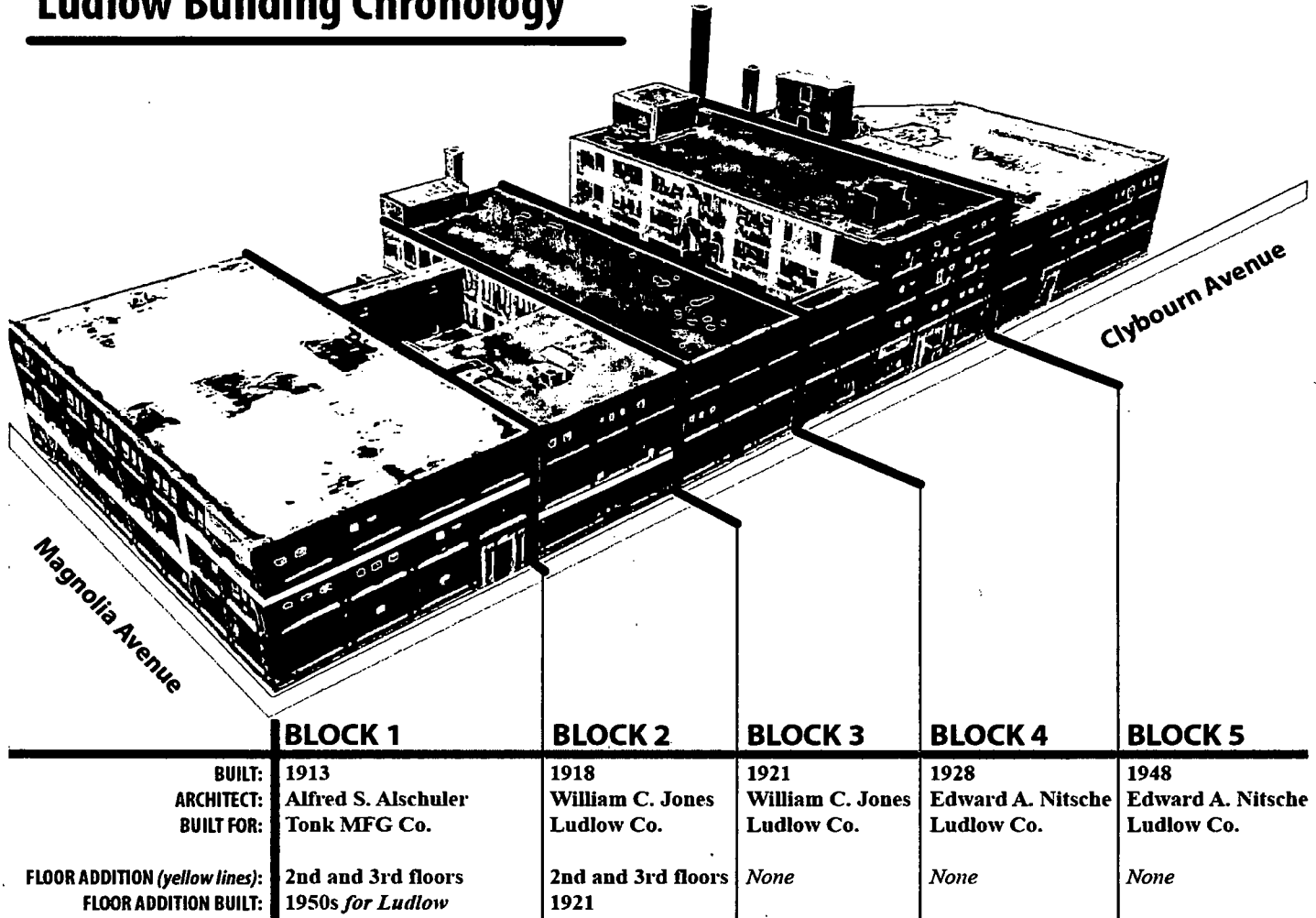


Landmark Building

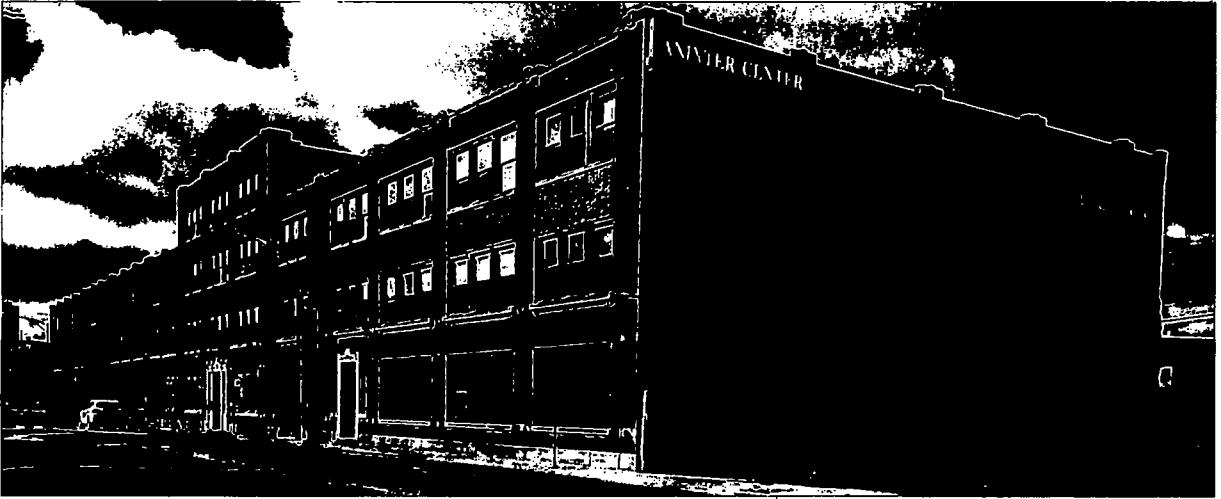

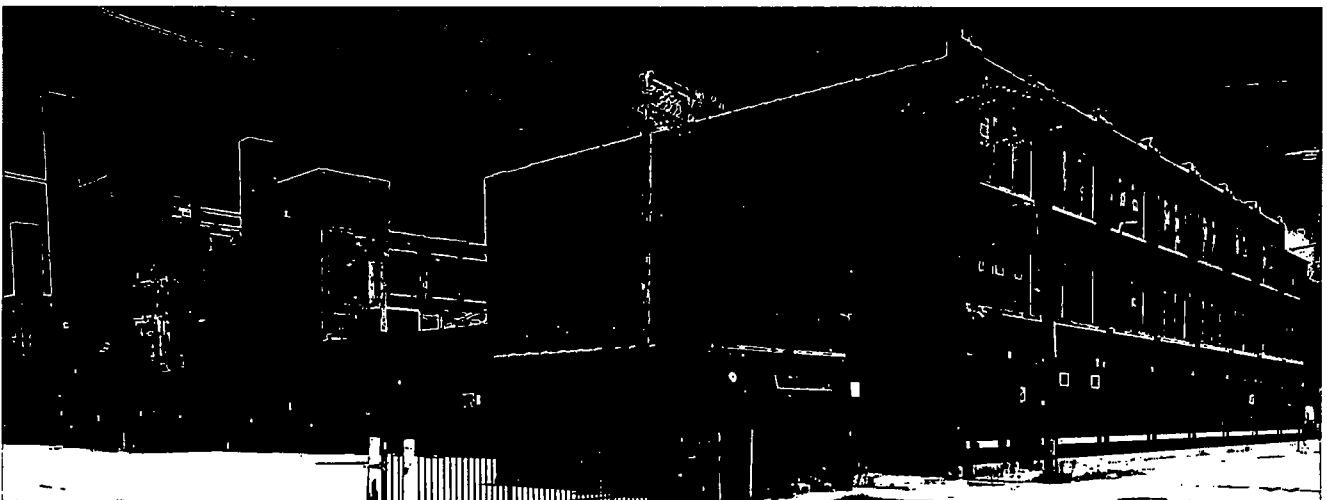

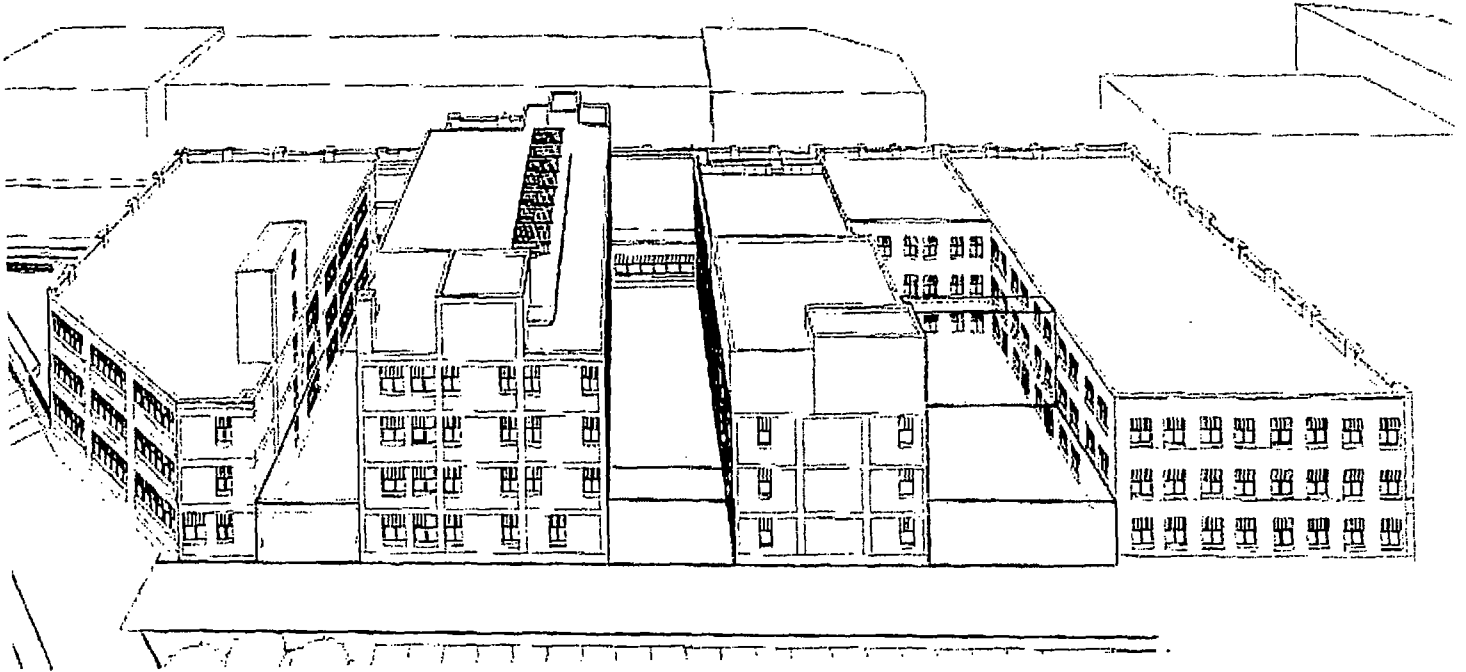

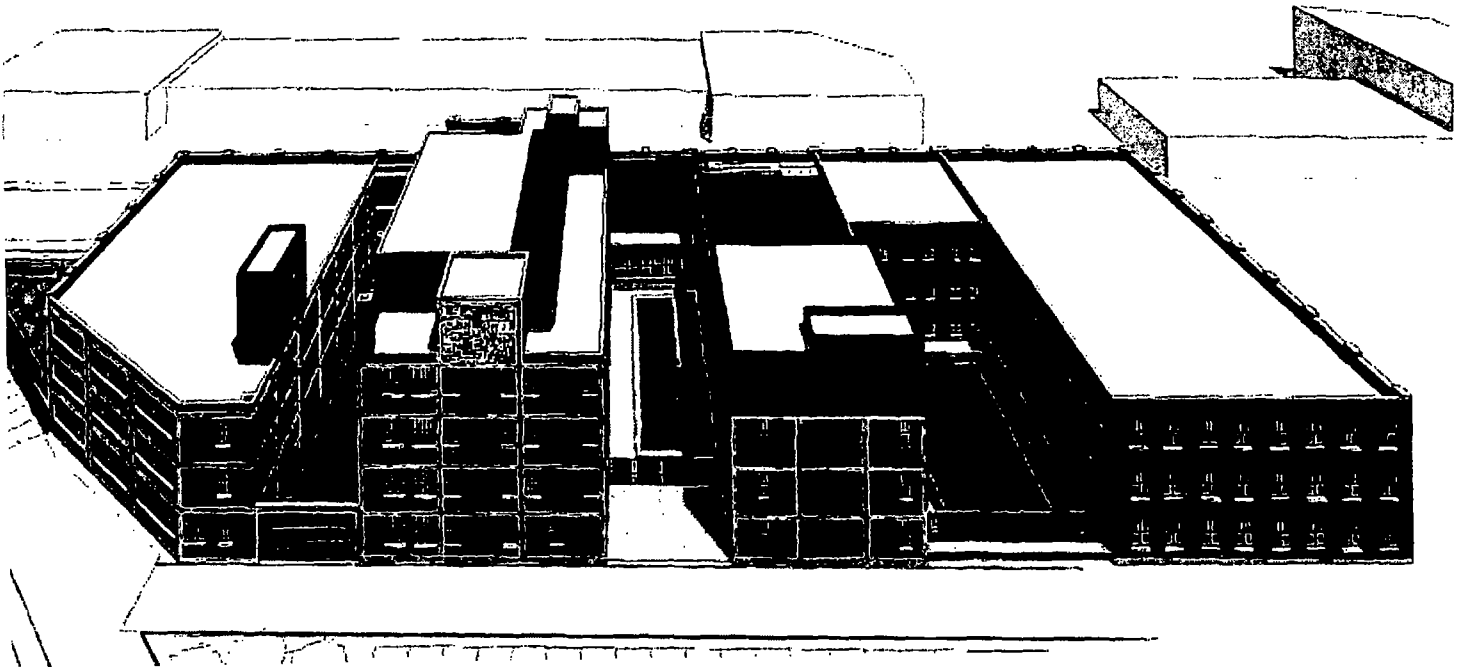

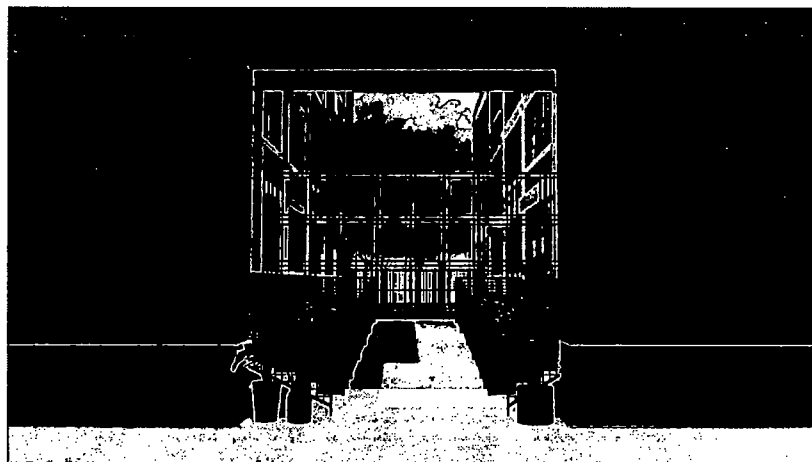
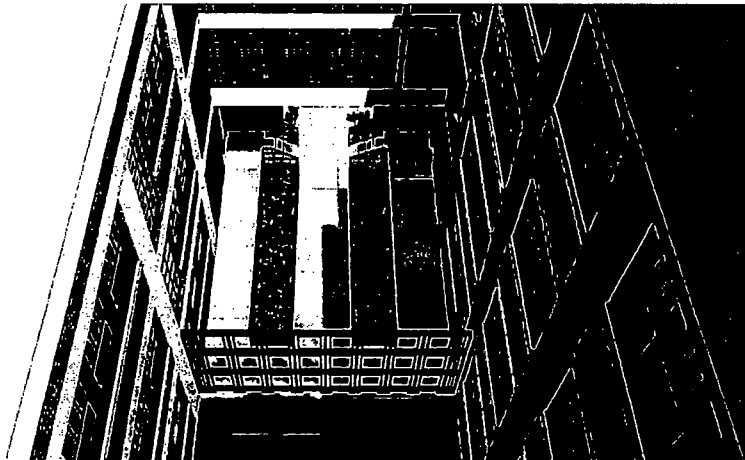
